COUNT 1


The Prosecuting Attorney of the County of Cole, State of Missouri, charges that the defendant, in violation of Section 573.040, RSMo, committed the class C misdemeanor of an attempt to furnish pornographic materials to a minor, punishable upon conviction under Sections 558.011 and 560.016, RSMo, in that on or about May 25, 2007, in the County of Cole, State of Missouri, the defendant, knowing its content and character, presented material pornographic for minors consisting of explicit written directions and descriptions of oral and manual stimulation of the vagina, by way of the Internet, to a person believed by the defendant to be a person under the age of eighteen years.

COUNT 2

The Prosecuting Attorney of the County of Cole, State of Missouri, charges that the defendant, in violation of Section 573.040, RSMo, committed the class C misdemeanor of an attempt to furnish pornographic materials to a minor, punishable upon conviction under Sections 558.011 and 560.016, RSMo, in that on or about July 6, 2007, in the County of Cole, State of Missouri, the defendant, knowing its content and character, presented material pornographic for

minors consisting of explicit written directions and descriptions of oral and manual stimulation of the vagina, nipples, breast and penis, by way of the Internet, to a person believed by the defendant to be a person under the age of eighteen years.

Comes now Officer Chad Stieferman states the following under oath:

1. I have probable cause to believe the defendant committed the crime of Furnishing Pornographic Materials to Minors (RSMo. 573.040) in that on or about 05-25-2007 and 07-05-2008 at 401 Monroe St. Jefferson City MO, Jefferson City, Missouri, County of Cole.


2. The facts supporting this belief are as follows:

The defendant committed the crime of Furnishing Pornographic Material to Minors on 05-25-2008 and 07-05-2008 by knowingly furnishing in written form material pornographic on nature to a female he believed to be only thirteen years of age.

On 05-25-2008 I was contacted on my undercover profile by the defendant via Yahoo Instant Messenger. The Defendant was using the screen name of "thebestinmo." The suspect knew that I was only thirteen years old because of prior chat conversations on Yahoo Messenger. At about 1614 hours the defendant stated to talk to me about masturbation. He asked when the last time I masturbated was and then told me that I need to try masturbating over the phone. He than asked what color bra and panties I was wearing and I responded by telling him I had on a white bra and red panties. He then stated to talk about sliding his hand underneath my panties and looking at what was underneath them. He then stated he would "love to make clit hard ... best way is to flick with a tongue."

On 07-05-2008 the defendant and I had another chat conversation. He talked to ma about masturbation and how to touch my breasts to make my nipples hard. He then stated "slide those panties off so you can spread wide and then take that finger and slowly rub int on your lips. Slowly up to your clit and feel how hard it is getting. Rub it gently, then a bit harder until it feels really good." He then asked if it felt good and then stated "take your fingers and slowly slide them deep inside that wet pussy. Just as you could imagine what a hard cock might feel like. Slide those fingers in and out. Getting them so wet. Then faster and faster. Making it feel really good I bet that is nice and tight." He then asked if I wanted to "cum" and stated "just imagine what a tongue would feel like flicking that clit rather than your finger there." He then stated that I would look sexy as I laid over his lap naked.

I swear, under penalty of perjury that the facts stated above are true to the best of my knowledge.
